

UNION ELECTIONS COMING APRIL Nominations to be held during March Meeting, Saturday 20th at 2:00 PM

Nominations will be held for President, Vice President, Recording Secretary, Treasurer, Guide, Two Guards, Three Trustees, and a Grievance Representative for each department.

The full eligibility requirements for nominees are laid out in the Union Constitution and the Local Union Elections Manual, Article VII section 9; an abbreviated form of the requirements is presented here. Some rules and requirements of previous years have been adjusted due to the cancellation of regular meetings during the COVID-19 pandemic.

The Member must have been in continuous good standing for the 24 months immediately proceeding the month in which the election is held. A Member who has transferred from one Local Union to another Local Union within the 24 month period prior to the election is permitted to count their time in good standing with their previous Union. The Member must be a member of the department or zone in which they wish to run, in the case of Grievance Committee-Persons.

Tellers for the upcoming election will be selected during the nomination meeting. Both the nominations and the election will be held in-person and on-site at the Union Hall. There will be no mail-in nominations or ballots.

More detail of the requirements and reasons above can be found in the Manual. You may obtain a copy of the Manual prior to the nominations from the Financial Secretary at the Union Hall, 4306 Huntington Ave. After the nominations you must contact the Tellers Committee.

The Union is very specific about this election and there are many guidelines that must be followed. It is definitely our intent to follow these rules and to assist you with any questions and concerns to the best of our ability.

Page 3 COVID-19 Vaccine Coming to Shipyard



Newport News Shipbuilding has acquired doses of the Moderna COVID-19 vaccine and will provide it to full-time employees free of charge.

The distribution model is on-going and will begin with Master ShipBuilders (those with more than 40 years of service) and employees over 60 years of age. Also included with the employees initially scheduled will be essential departments and first responders.

Scheduling will be on-going and handled through management, contact your supervisor about requesting a vaccine. Vaccinations will take place at the Old Apprentice School Gymnasium (Bldg. 601) transportation to and from the site will be provided and workers who take the vaccine during work hours will be paid for the time it takes (up to 1.5 hours). You must have your badge and schedule ticket from your supervisor in order to receive the vaccine.

On receiving your first dose, you will be given a ticket informing you of your time to receive the second. It is vital that you receive the second dose on time.

Political Action Committee

Welcome to 2021 my fellow shipbuilders. I look at this year with more optimism than 2020 for many reasons. With any luck we will be able to return to our restaurants, bars, churches, cookouts, concerts and sporting events. It will take a lot of cooperation from everyone to achieve this but it is more possible than in 2020.

Of course in Virginia there is always politics. We vote every year and sometimes 2 or 3 times a year. This year will be no different with primaries in June for candidates seeking the governorship, Lt. Governorship, and Attorney General. Every Delegate position is up for reelection also in the General Assembly.

This year our General Assembly has been very busy, and very virtual in considering legislation. Among pieces of legislation that the unions have been lobbying, has been legislation covering repetitive injuries in the workplace. This is the second year in a row for this legislation and as we point out to our representatives we are the only state in the United States where these injuries are not covered by worker's compensation.

Other interesting legislation that the unions are working on include workers protections from heat exhaustion, workers rights to sick leave, workers rights to overtime pay, workers rights to refuse unsafe working conditions, assuring Virginia purchases safety equipment from USA companies and workers, and assuring that all infrastructure projects in the state of Virginia are given only to companies using American workers. There are more pieces of legislation we are following and hoping to get passed. Since this is a short session of 30 days, unless extended by the Governor the March Voyager or April Voyager will cover any bills that were passed which affect our workforce.

When one complains about the union being involved in politics, one should remember if we do not have a seat at the table then the enemies of workers' rights get free reign over all legislation passed. That is not in our best interest for wages, benefits, or safety.

FEBRUARY, 2021 BUILDING TO START ON MARY WINSTON JACKSON NEIGHBORHOOD CENTER



The work of four years by your United SteelWorkers Local 8888 and other community leaders is coming to fruition. In 2017 we lead a petition to honor our local hero Mary Jackson, the first African American Woman Engineer in the American Space Program, by naming a street, park or public center for her. Mary Jackson was born and lived in Hampton. She broke through many barriers in her career, clearing the way for those who would follow in her footsteps.

Last March the final design of the new Mary Winston Jackson Neighborhood Center were accepted, and this year construction is set to begin. It is scheduled to open next spring.

The center's design features a full-sized gymnasium, a kitchen, meeting areas and open spaces, as well as parking.

Today, the soul of Mary Jackson has come home to the community that raised her and later revered her. United Steelworkers Local 8888 is proud to be part of the ground- breaking ceremony for the new Mary W. Jackson Neighborhood Center in the Hampton community she loved dearly.

Throughout her prolific career, Mary Jackson broke new ground and opened doors for thousands to follow. It wasn't easy, though. As a Black woman in the South, she endured segregated rest rooms and cafeterias and other indignities in the workplace. She persevered and eventually helped put the first American astronaut into space as NASA's first Black female engineer. Millions around the world were exposed to Mary Jackson's genius and proud resolve in the 2016 film "Hidden Figures."

Thankfully, she is hidden no more in her hometown. The importance of naming of this center for an iconic African American woman cannot be overstated. For too long, the images and successes of Black women have been devalued or erased from our national and local history. Now, young girls and female students of all colors will be able to see and feel a connected to a city facility that validates their dreams and says the lives of Black women really do matter.

Local 8888 is proud our petition drive four years ago ignited this fitting tribute to Mary Jackson. We collected more than 2,500 signatures, lobbied city hall, partnered with social groups like Ms. Jackson's sorority, Alpha Kappa Alpha, and met with city planners This is a defining achievement for our union. I want to thank our members who were determined to see something meaningful and dignified for Mary Jackson. I also want to recognize Ms. Donna Little, a longtime member of Local 8888 and a fierce community advocate who worked tirelessly to have a neighborhood center rebuilt in her Olde Hampton community.

I will always remember this day, because it is part of the celebration of Black excellence at a time when our nation is straining to find unity and reconciliation. Honoring this strong Black woman for her genius and service has brought us together as a proud community. And that's how our ancestor, Mary Jackson, would want it.


